## **PrimeXBT 100% Promotion Code and Bonus Usage T&Cs**

### **Introduction**

These 100% Promotion Code and Bonus Usage T&Cs (the “100% Promotion Code Terms”), shall apply and govern the granting and usage of the 100% Promotion Code (the “Promocode”), the participation of Clients in this Promotion and the usage of the bonus offered to new and/or existing Clients (the “Client(s)”, “you”, “your”) of Prime XBT Trading Services Ltd, a company incorporated and existing under the laws of Saint Lucia, with Registration No. 2024-00343, having its registered office address at PKF Corporate Services Ltd., 1st Floor, Meridian Place, Choc Estate, Castries, Saint Lucia (hereinafter referred to as “PrimeXBT”, the “Company”, “we”, “us”, “our”, as appropriate).;

Your usage of the Promocode and bonus shall equate to your full and unequivocal acceptance of these 100% Promotion Code Terms, the General Rules of Promotion Codes & Bonus Usage Terms & Conditions, and the General PrimeXBT Terms & Conditions that govern the relationship between the Company and all of its Clients, and all relevant Policies (collectively referred to herein as the “Terms”), the latest versions thereof being available at all times on the PrimeXBT Website, as amended from time to time.

## **1. Participation Eligibility**

- 1.1.** PrimeXBT offers its Clients the opportunity to receive a bonus equivalent to one hundred percent (100%) of their deposit in their respective trading Account or Wallet (the "Bonus"), subject to the use of the designated Promocode (i.e. ***"Ramadan25"***) and participation in this promotional offer (the "Promotion").
- 1.2.** To qualify for participation in this Promotion, Clients must satisfy the following conditions:
  - 1.2.1.** The Client must be duly registered with a valid trading account on the PrimeXBT trading platform.
  - 1.2.2.** The Client Account must be in good standing, as determined by the Company at its sole discretion.
  - 1.2.3.** The Client must make at least one (1) deposit during the promotion period, as specified in Paragraph 2.1. of these terms.
  - 1.2.4.** The Client must be a legal resident in Malaysia, India or Pakistan.
- 1.3.** Employees of PrimeXBT or any other affiliated company and their immediate family members shall not be eligible to participate in any Promotion, and are thus expressly excluded. Additionally, employees of any partners and agencies involved in the organization or conduct of the Promotion, as determined by PrimeXBT, shall not be eligible to participate in Promotions. The Promotion is also not open to employees of any other company engaged in direct competition with PrimeXBT.

## **2. Promotion Duration**

- 2.1.** This Promotion shall be valid exclusively for the period commencing on March 5, 2025, and concluding on March 29, 2025 (the "Promotion Period"), subject to the terms and conditions herein and any modifications as may be announced by the Company at its discretion.

## **3. Limitations and Conditions**

- 3.1.** The Bonus shall be granted as one-time credit on the Client's initial deposit made during the Promotion Period. Clients shall not be entitled to receive additional Bonuses on subsequent deposits made during the Promotion Period.
- 3.2.** The maximum Bonus amount that can be granted under this Promotion is USD10,000.
- 3.3.** Once activated, the Promocode remains valid for fourteen (14) days.
- 3.4.** The Bonus is non-withdrawable and may only be utilized for trading purposes on the PrimeXBT trading platform, subject to the Company's General Rules of Promotion Codes & Bonus Usage Terms & Conditions.

## **4. General Rules**

- 4.1.** If any restrictions apply to the Client's Account, the account shall not be able to use Promotion Codes nor shall it qualify for a Bonus until the restrictions have been lifted.
- 4.2.** PrimeXBT shall not be liable for any losses that may be incurred as a result of trading while participating in a Promotion Campaign or through the usage of Bonus Credit.
- 4.3.** Promotion Codes and Bonuses must only be used for personal and non-commercial purposes.

- 4.4.** If PrimeXBT subsequently discovers that a participant is not eligible to participate in Promotions and receive Bonuses, PrimeXBT may then at its discretion invalidate any granted Promotion Codes or reverse and withdraw any Bonuses credited. No individual shall be entitled to any payment or compensation from PrimeXBT should any Bonus Credit or corresponding profit be forfeited, or reclaimed.
- 4.5.** PrimeXBT reserves the right to cancel or revoke Promotion Codes and/or withdraw Bonuses Credited via Promotions and annul all or any portion of profits made when using the Bonus at any time, in case of any suspected abuse of the Promotion Codes/Promotion Campaigns by a participant, including but not limited to using multiple Promotion codes on multiple accounts to mirror trades.
- 4.6.** In the event that any Client Deposit is cancelled, clawed or charged back, returned from the bank for insufficient funds, fraud, or any other reason, the Client will become ineligible for a Bonus, and PrimeXBT has the right to reclaim and withdraw all or any portion of a Bonus credited to any Account or Wallet under a Promotion.
- 4.7.** The decision of PrimeXBT on all matters relating to Promotions and Bonuses shall be final and binding on all participants. PrimeXBT reserves the right to cancel, revoke, or withdraw the Promotion and/or withdraw any credited bonuses to any Client Wallet or Margin Account at any time and without the obligation to provide any reasons or explanations.
- 4.8.** Clients acknowledge that PrimeXBT may, at any time in its sole and absolute discretion, without notice, terminate Promotions and Bonuses, or delete, vary, supplement, amend, restrict, withdraw, or modify any one or more of the Terms in such manner as PrimeXBT shall think fit, including without limitation, the eligibility of any Client, the bases and methods of identification of participating Clients, and any dates in connection with the Promotion and the Promotion period/duration.
- 4.9.** Promotions and Bonuses cannot be used in conjunction with any other rebate, commission reduction, promotion, or similar scheme offered by PrimeXBT.

- 4.10.** Participation in this Promotions shall be limited to one Client Account per person. Multiple accounts from the same household may be barred. Bonuses may apply to multiple Margin Accounts per Client.
- 4.11.** Joint accounts or accounts with a Power of Attorney in force will not be eligible for Promotions and Bonuses.
- 4.12.** Only natural persons with full legal capacity and who are over eighteen (18) years of age shall be eligible for this Promotion.
- 4.13.** This Promotion's expiry date and specific terms shall be made available to the public through the PrimeXBT Website or relevant Marketing campaigns.
- 4.14.** PrimeXBT reserves the right to deny participation to Promotions or terminate a Client's participation in Promotions if it reasonably believes that there has been cooperation, collusion, or organization of trades and market manipulation, or if it believes in its discretion that the Promotion in question is being abused by the terminated participant in any way.
- 4.15.** By submitting their details and particulars to a Promotion, Clients consent to PrimeXBT using or sharing such information for the Marketing efforts of PrimeXBT, its Affiliates and/or its Partners or Sponsors. Participating Clients must inform PrimeXBT if they do not wish to receive such information by contacting PrimeXBT's Customer Service Team.
- 4.16.** Clients acknowledge that PrimeXBT shall not be liable for any claims, costs, expenses, losses, or damages suffered by any person as a result of engaging with this Promotion.
- 4.17.** PrimeXBT shall not be liable to any Client, or any other person, for any loss, tax liability, or damage arising in connection with this Promotions, including any error, technical malfunction of the World-Wide Web (internet) or the PrimeXBT Website or Trading Platform, or any breakdown or malfunctions in any computer system, mobile application, downloadable software, or equipment, including that of the Client.

- 4.18.** Any dispute not covered by these 100% Promotion Code Terms will be resolved by PrimeXBT in a manner it deems to be the fairest to all concerned, and that decision shall be final and binding on all parties.
- 4.19.** These 100% Promotion Code Terms are governed by the laws of Saint Lucia.
- 4.20.** If any term of the Promotion Terms is found to be illegal, invalid, or unenforceable under any applicable law, such term shall be severable from the remaining terms, and the remainder of the Promotion Terms shall remain valid and binding as if the severed term had never been included.
- 4.21.** If these 100% Promotion Code Terms are translated into a language other than English, then the English version of the Promotion Terms shall prevail wherever any inconsistency arises.
- 4.22.** The Client acknowledges and agrees that the availability of certain products, bonuses, promotions, campaigns, prizes, platforms, and services may be restricted or unavailable in certain jurisdictions, subject to the Company's sole discretion.
- 4.23.** These 100% Promotion Code Terms are subject to change at PrimeXBT's discretion, and its decision is final. PrimeXBT is the sole arbiter of these 100% Promotion Code Terms and any other issue arising under this Promotion.

## **5. Jurisdiction and Dispute Resolution for Dual Legal Relationship Clients**

**5.1.** These below terms shall exclusively apply to clients who, during the account registration process on primexbt.com and/or any other websites operated by the Company, have explicitly established a dual legal relationship with both **PrimeXBT Trading Services Ltd**, a company incorporated under the laws of Saint Lucia (Registration No. 2024-00343), and **PXBT Trading Ltd (“PXBT”)**, a licensed Securities Dealer authorized by the Seychelles Financial Services Authority (License No. SD162). Clients who form such a relationship are bound by the following provisions, which govern the respective services provided by each entity and their applicable jurisdictions.

### **5.1.1. CFD Trading and Related Services**

Disputes, complaints, claims, or legal proceedings arising from or in connection with CFD trading services provided via the MetaTrader 5 platform or any related services offered by PXBT Trading Ltd shall be governed by the laws of Seychelles and subject to the exclusive jurisdiction of its courts.

### **5.1.2. Crypto Futures Trading and Wallet Services**

Disputes, complaints, claims, or legal proceedings related to crypto futures trading services and crypto wallets provided by PrimeXBT Trading Services Ltd shall be governed by the laws of Saint Lucia and fall under the jurisdiction of its courts.

### **5.1.3. Acknowledgment and Agreement**

Clients acknowledge that disputes and claims shall be handled in accordance with the jurisdiction of the specific entity responsible for the relevant service and governed by the respective Terms and Conditions.

### **5.1.4. Applicability of Terms to PXBT Trading Ltd**

5.1.4.1. It is expressly clarified that these terms apply to PXBT Trading Ltd for all cases involving CFD trading or the use of services via the MetaTrader 5 platform, with governance subject to the laws and jurisdiction of Seychelles.

5.1.4.2. For clients who have established a dual legal relationship with both PXBT Trading Ltd and PrimeXBT Trading Services Ltd as specified during the account registration process, any references within this policy to "PrimeXBT," "the Company," or similar terminologies shall be understood to include PXBT Trading Ltd as well with regard only to the services and products provided by PXBT Trading Ltd.
